





# Fair Regulations

## General rules for merchandise

At the O M G Militaria Fair it is only permitted to offer militaria that does not conflict with Dutch law. For example, traders may offer for sale: army vehicles, vehicle parts, military (repro) clothing, equipment, utensils, helmets, badges, medals, tools and other aids for the restoration of army vehicles, vintage (repro) civilian clothing from the period 1940-1945. , historical books and DVDs and other WWII related items. All irrelevant antiques and grandmother's items are not allowed.

Warning: It is strictly prohibited to offer weapons or replicas, weapon parts, blank weapons and ammunition for sale at the Militaria Fair of O M G In accordance with Dutch law, it is prohibited to exhibit, sell or exchange any object that could give rise to racial politics or xenophobia, including all Nazi memorabilia.

#### Registration as a trader

#### We expect 10.000 visitors throughout the week

Up to one (6) weeks before the start of the fair on September 14, 2024, which is before or on August 3, 2023, it is possible to reserve one or more locations via the OMG website. Participation in the Militaria Fair is only final after receipt of the registration form and after receipt of payment of the invoice.

The Fair committee allocates the locations of traders according to availability and will take the wishes of a trader into account as much as possible when allocating. The Fair committee has the right, without stating reasons, not to allocate or to partially allocate the location reserved by a trader.

Please note: any sales activity outside the O M G Militaria Fair on the O M G event grounds is prohibited

All traders are obliged to take out civil liability insurance for participation in trade fairs (trunk sellers only need third-party liability insurance for private individuals; companies must have liability insurance for companies).

## Admission tickets

As a merchant, you will receive two wristbands for the first location, one for you and one for your employee. You will receive an additional wristband for each subsequent location, with a maximum of five wristbands. Other employees are seen as visitors and must purchase an entrance ticket. The use of the toilets and shower is free.







#### Setting up the sales area

You can rent a plot or rent several closed plots for the entire week of 6 meters x 6 meters for the price of  $\in$  250 for the entire time from Friday September 13 to Monday September 23.

If you only want to come the first weekend, September 14 and 15, you pay  $\in$  180 for a plot of 6 meters x 6 meters. For the second weekend, September 21 and 22, you pay  $\in$  180

The numbers on the ground locations indicate the location of merchant locations using assigned location numbers. Please ensure that you do not set up your stand in a location other than the one assigned to you, or outside the indications on the ground.

Trucks and/or trailers as a sales point must be located on the plot of land you rented, they may not be parked outside, you can also park your truck or trailer in the parking lot, from which no sales can be made, If you wish, you can set up on Friday, September 13, and dismantle on Monday, September 23 at your assigned location.

The fair is from Saturday afternoon, September 14th to Sunday afternoon, September 22nd at 12:00 noon. You can be present on all days, for which you have paid.

There are no market stalls for rent from the fair organization and only plots of 6 meters x 6 meters can be rented. Vehicles, trucks and trailers of traders that do not fit on your stand must be parked in the parking lot. Follow the organization's instructions about this.

The exhibition committee will rent tents measuring 5 x 5 meters that will be set up on Friday, September 13 and dismantled on Monday, September 23 after 12 noon by the tent builder.

These tents of 5 x 5 meters can be rented for the price of  $\in$  400 for the entire period

**PLEASE NOTE:** It is allowed to spend the night on the exhibition grounds, even during the entire week, <u>but it is in your self braught tents and they</u> must stand on your rented plot

## Tidy

Because the fair is open to visitors from 9:00 AM to 6:00 PM, traders are only allowed to clean up and leave their sales location on evenings after 6.00 PM and after 12:00 PM on Sunday, September 22. The exhibitor undertakes that his rented site is left clean. any clean-up

costs will be recovered from the exhibitor.

All traders must leave the site by 12 noon on Monday 23 September.







### Garbage

All traders must leave their premises neat and tidy at the end of the Militaria Fair. As an organization, we expect that you take all the waste and other rubbish with you afterwards. You will be charged  $\in 10.00$  per kilo for leaving behind <u>also garbich</u> <u>large/coarse waste.</u>

# Violation of Fair regulations

All traders are bound by these Fair regulations. They will immediately follow the instructions, arising from situations of force majeure, from the O M G organization (and from the O M G volunteers), and legal authorities (police, fire brigade). In the event of any disputes, the participant will accept the decision of the organization. Failure to comply with the fair regulations may result in immediate suspension and removal without the right to any compensation. In case of discussion, the Fair regulations in the Dutch language apply. In the event of a violation of Dutch legislation regarding (replica) weapons and/or Nazi memorabilia, the exhibition committee is obliged to inform the police.

# Liability

If, in the event of force majeure, holding the O M G Militaria Fair is impossible, the registered traders can under no circumstances claim any compensation.

The Fair Committee and the board of the O M G association can never be held liable for the loss, theft, disappearance or any damage to property of third parties, nor for accidents or personal injury incurred during the O M G Militaria Fair.

Any damage caused by a trader or his employee(s) will be repaired at his expense.
